
The dedication to Laxå as a location manifests itself in a variety of ways.

## "I VERY MUCH ENJOY LIVING IN LAXA"

Maria Thor began Sjöbod No. 7 in Laxå in 2015. Since then, things have moved quickly, and they have grown the business from a small 60-square-meter shop to a 340-square-meter shop.

We sell home furnishings and carry a variety of well-known and larger brands. We get a lot of customers from all over Sweden because of our geographical location, says Maria.

Sjöbod No. 7 is right next to E20, near the restaurant area. Up to 70% of all customers in Maria's shop are passing through, either between Stockholm and Gothenburg or on their way to or from the mountains up north.

– The location is fantastic; this is where you stop for a coffee or lunch on the go, and our customers come from all over Sweden, she says. Maria lives in Laxå and enjoys it very much. During the summer, she also runs Sjöbod No. 7 on Öland, while her employees look after the business in Laxå.

I used to live a little farther out of town, but
I moved in to be closer to work. It's a fan-

tastically nice place to live, close to nature and with a good sense of community.

### What is it like to be an entrepreneur in Laxa?

In my opinion, it's fantastic!
 On Mondays, the municipality's business owners gather for a joint luncheon where we can network, and I think it's great that the municipality stays active.

We don't need the municipality's assistance, but it's nice that they for instance brought flowers when we celebrated our five years in business, and we do have a good relationship.






### LAND FOR EVERY NEED

Laxå Municipality sells zoned land for businesses in Laxå and Finnerödja. Many businesses see several benefits from our attractive location in the heart of Sweden when it comes to running their operations in an efficient and favorable manner. 70% of Sweden's population is within 30 miles of Laxå, and we have both Sweden's fourth largest airport and the Nordic region's largest logistical railway point right around the corner. All available vacant land can be found at www. laxa.se, and the sale is completed in six steps:

- **1. First point of contact.** You find a vacant plot of land that interests you and contact us to express your interest.
- **2. Feasibility study.** We agree not to sell the plot of land to anyone other than you while the feasibility study is being conducted. The feasibility study is free, but you must present a proposal on how and what you intend to build on the land during this period. A group of officials will evaluate the proposal and when the proposal is accepted you can move on to the reservation agreement.
- **3. Reservation agreement.** A reservation agreement is a six- to twelve months agreement between you and Laxå Municipality. In the agreement, we agree to sell you the land on the condition that you apply for and receive a building permit and begin construction. You pay 10% of the final sales price for the reservation.
- **4. Purchase contract.** Purchase agreement. We will sign a purchase agreement after you have met the requirements within the reservation period, and only then will you pay remainder of the purchase price.
- **5. Purchase deed.** Bill of sale. When the purchase price has been paid, the bill of sale is issued. Now you can register and mortgage your new property.
- **6. Land price.** Land is priced per square meter. The square meter price is set according to attractiveness through political decisions at the latest at the conclusion of the reservation agreement.
